Product description

This recall involves three Home Accents Holiday Artificial Christmas Trees sold by Home Depot. The trees can be identified by the names, description, model numbers, and UPC in the table below.

Hazard identified

The Christmas tree's mode-switching foot-pedal controller may overheat, posing a burn or fire hazard.

As of July 22, 2020, the company has received 2 reports of smokes coming from the trees in Canada, and no reports of injuries. In the United States, the company has received 491 reports of overheating involving the foot-pedal controller, and one report of burn.

Number sold

Approximately 5,095 units of the affected products were sold in Canada, and approximately 99,000 units were sold in the United States.

Time period sold

The affected products were sold from September 2019 to December 2019.
